The Town of St Joe Waterworks passed all water testing. All Lead reporting has been submitted and the public notices posting in the Star newspaper.

The trailer park has caused excessive water loss for the Town of St. Joe. In with legal fees and burden of proof the town doesn't feel the return of legal fees will be worthwhile. Waterworks ordinance states excessive water rate in the amount of \$25 per day since legal notice for excessive water usage can be added to the bill. Angela Snyder presented the Appropriation Report. Randy Drake motioned to approve the appropriation report. Zebulon Griggs second the motion. All ayes cast.

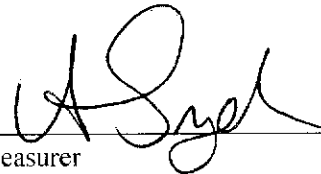
Angela Snyder presented the receipts for review. Randy Drake motioned to approve. Zebulon Griggs seconded the motion. All ayes cast.

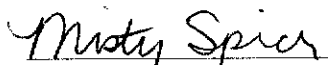
ADJOURN:

Randy Drake made a motion to adjourn the meeting at 7:58pm. Misty Spicer seconded the motion. All ayes cast.

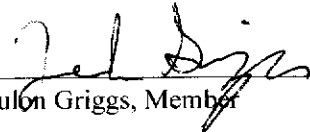
