Angela Snyder presented the receipts report for the boards review. Randy Drake motioned to approve the receipts. Zebulon Griggs seconded the motion. All ayes cast


Angela Snyder presented the Fund report for July. Randy Drake motioned to approve the Fund report. Zebulon Griggs second the motion. All ayes cast.


Angela Snyder would like to transfer money into the payroll account to make it a positive balance, she will speak to George during budgeting meeting.


The Town hall has access to Mediacom. Angela Snyder would like to get Mediacom service for the internet and phone the amount per month difference is average \$60 per month.


ADJOURN:
